- The state has changed R470 language – universities can only have 27 GE credits and an additional 3 GE credits for an institutional unique course to fill any GE gaps.
- At least 5 credits in each program will need to be adjusted
- GE Taskforce is reformed – Town Hall meetings will occur on January 26 and February 1
