IS THE OCCURRENCE OF POLICE BRUTALITY AND USE OF FORCE INCREASING, OR IS THE INCREASE IN EXPOSURE IN THE MEDIA LEADING THE GENERAL POPULATION TO AN INCORRECT CONCLUSION ON THE OVER USE OF FORCE?

- DO UVU STUDENTS BELIEVE USE OF FORCE HAS INCREASED ALONG WITH VIOLENCE? OR ARE OUR LAW ENFORCEMENT OFFICERS OUT OF CONTROL?
- OR ARE UVU STUDENTS UNCARING ABOUT USE OF FORCE SITUATIONS?

WHY?

- NOT ONLY AS CRIMINAL JUSTICE STUDENTS BUT AS PEOPLE IN OUR COMMUNITIES, WE WANTED TO SEE IF UVU STUDENTS BELIEVED THAT THE MEDIA HAD A STRONG INFLUENCE ON THEIR PERCEPTION OF POLICE BRUTALITY AND USE OF FORCE WHETHER IT BE POSITIVE OR NEGATIVE.
- WE ALSO WANTED TO SEE IF THE UVU STUDENTS WERE IN ANYWAY RELATED TO LAW ENFORCEMENT, AND/OR IF THEY HAD ANY PREVIOUS ENCOUNTERS WITH LAW ENFORCEMENT

PAST STATISTICS

- ON AVERAGE, THERE ARE APPROXIMATELY 385 INDIVIDUALS JUSTIFIABLY KILLED BY LAW ENFORCEMENT EACH YEAR (US DEPARTMENT OF JUSTICE, 2010).
- THE MOST COMPREHENSIVE RESEARCH ON MISCONDUCT OF POLICE OFFICERS BEING COMPLETED BY THE NATIONAL POLICE MISCONDUCT AND REPORTING PROJECT IN 2010,. THE NPMRP FOCUSES AROUND DATA GATHERED FROM JANUARY 2010 TO DECEMBER OF 2010. OF THE 6,613 LAW ENFORCEMENT OFFICERS INVOLVED IN REPORTED ALLEGATIONS OF MISCONDUCT THAT MET NPMSRP CRITERIA FOR TRACKING PURPOSES, 1,575 WERE INVOLVED IN EXCESSIVE FORCE REPORTS, WHICH WERE THE MOST PROMINENT TYPE OF REPORT AT 23.8% OF ALL REPORTS. (NPMSRP 2010)

SURVEYING UVU STUDENTS

- WE RANDOMLY SELECTED 500 RANDOM UVU STUDENTS TO DETERMINE IF THEY BELIEVED THERE WAS AN INCREASE IN POLICE BRUTALITY OR USE OF FORCE CASES.
- QUESTIONS ASKED WERE USED TO DETERMINE IF THEY FOLLOWED THE MEDIA, IF THEY WERE AFFILIATED WITH LAW ENFORCEMENT, THEIR OPINIONS OF CRIME, AND MANY OTHERS.
- OUT OF THE 500 STUDENTS WE SENT THE SURVEY OUT TO WE HAD AN AVERAGE OF 50 RESPONSES. THE AVERAGE TIME TO COMPLETE THE SURVEY WAS EIGHT MINUTES.


DEMOGRAPHICS

- AGE: 49% OF PARTICIPANTS WERE BETWEEN THE AGES OF 18-25, A CLOSE SECOND WAS THE AGE RANGE OF 26-35 WITH 32%
- GENDER: 66% OF THOSE WHO RESPONDED WERE MALE
- RACE: 85% IDENTIFIED AS WHITE 9% AS HISPANIC, 2% AS AFRICAN AMERICAN, 2% ASIAN, AND 2% NATIVE AMERICAN

FAMILIARITY WITH LAW ENFORCEMENT AND LAW:

- 86 % OF THE SURVEY PARTICIPANTS SAID THEY WERE NOT PERSONALLY INVOLVED WITH LAW ENFORCEMENT OR HAD AN IMMEDIATE FAMILY MEMBER IN LAW ENFORCEMENT
- OUT OF THE 7% WHO WERE INVOLVED OR KNEW SOMEONE WHO WAS, 50% WERE POLICE OFFICERS, 33% WERE CORRECTIONS AND 17% WERE INVOLVED IN OTHER AGENCIES.
- WITH THE LOW NUMBER OF THOSE INVOLVED WITH LAW ENFORCEMENT, WE WERE CURIOUS ABOUT HOW WELL THEIR KNOWLEDGE WAS ABOUT USE OF FORCE...





- ACCORDING TO UVU STUDENTS AND THEIR RESPONSES WE GATHERED, WE COULD COME TO THE CONCLUSION THAT BECAUSE THEY WERE INVOLVED WITH MEDIA THAT THEY COULD DEFINITELY BE INFLUENCED BY THE MEDIA STORIES BOTH POSITIVE AND NEGATIVE. BUT WITH THE LACK OF RESPONSES THERE WAS NO CLEAR TRUTH TO WHETHER MEDIA HAD A TRUE INFLUENCE ON THEIR OPINIONS.
- WE ALSO SAW THAT A LARGE AMOUNT OF UVU STUDENTS OPENED THE SURVEY BUT CHOSE NOT TO TAKE IT. WE COULD ALSO SEE THAT SOME QUESTIONS WERE SKIPPED OVER AND WE COULD ASSUME THAT THIS TOPIC WAS NOT OF INTEREST TO CERTAIN UVU STUDENTS.
