- Academic Integrity Survey, Preliminary Report:
  - o 254 Faculty responses and 1788 Student responses
    - Summer Analysis:
      - Will analyze results from questions where students and faculty differ on their views on what is considered cheating
      - Analyze results on what consequences are appropriate for academic dishonesty
    - Insights and Potential Initiatives:
      - Provide more information to faculty on academic misconduct
      - Create a departmental or school/college wide model for handling academic integrity issues
      - Streamline process for submitting academic dishonesty to student conduct
      - Develop innovate ways to assess students to prevent academic dishonesty

### AI Task Force Update: Sam Gedeborg and Trish Baker

- Focus was on increasing faculty confidence and skillset with generative AI
- Best way to learn AI is to get your hands dirty it's an experience as you try it out and you'll get better as you use it
