Matriculation Requirements

1. "Application for admission...*by the established deadline.*" (Add italic text)
2. Submit official transcripts from all universities attended. (Add this requirement)
7. Include a statement that meeting minimum admissions criteria does not guarantee admission to the graduate program.

If the program accepts international students, add the following additional matriculation requirements:

5. "For international students..." (Add this requirement)
6. "International students must also meet US gov't requirements..." (Add this requirement)

Graduation Requirements – Add the following requirements

10. Graduate coursework completed within six-year period.
12. Cumulative GPA of 3.0 or higher shall be maintained in graduate program courses.
13. Graduate credits accepted from another regionally accredited institution or equivalent shall have been completed within four years of the graduate student's matriculation into the graduate program and

cannot be older than six years at the time of graduation with a master's degree or graduate certificate from the University.

Graduate Faculty Eligibility Requirements

College of Science graduate faculty recommended no changes to the [College of Science Graduate Faculty Eligibility Requirements](#). Graduate Council approved these requirements.

Duolingo English Proficiency

The Council discussed allowing each graduate program to determine whether they want to use Duolingo scores. Weber State University allows each program to determine whether they want to use these scores.

The Council discussed setting a minimum score for programs. It was recommended that Jim Bailey reach out to Andrew Stone and Eric Humphrey to see if they can find out how other Utah universities established their Duolingo minimum acceptable scores. The Duolingo issue was tabled until the Council get more information about how other universities decided to set minimum scores for Duolingo.

Discussion about Graduate Nomination and Election Templates for Faculty Senate Service and Elections Representatives

The Council discussed situations when there is only one nominee for a position. The Council recommended a ratification nomination for Graduate Council and Graduate Program Director positions, which normally occurs only every three years.

The Council was split on the ratification issues for Graduate Program Committees. The nomination email should encourage discussion of these graduate program committee positions. If no ratification is required where there is only one nominee, the nomination email should contain a statement that if there is only one nominee, the sole nominee will be considered elected.

Update on Strategic Enrollment Management Plans

Strategic Enrollment Management Plan data were given to each graduate program director. Jim Bailey and Laurie Sharp are meeting with graduate program directors and associated deans by college to discuss the plans and to answer questions. The plans are due on April 1, 2024.
