Graduate Council Guidelines

Discussed sharing Graduate Council Guidelines for evaluating faculty qualifications and curriculum with links to important documents. Consider having smaller groups of faculty review faculty and curriculum to spread the workload. Consider draft of Graduate Council Guidelines at next meeting.

Proposed Amendment to Policy 658

Considered adding the following section:

4.5.1.2 For graduate programs with specific graduate program director specialized accreditation requirements, a dean may appoint a faculty or staff member to be a graduate program director.

Several concerns were expressed. One concern was that the revised language may negatively impact specialized accreditation where active faculty involvement in selecting the graduate program director is required, but the graduate program director is appointed. Another concern was that deans may appoint graduate program directors where there is really not a specialized accreditation reason for doing it. If several graduate faculty meet the graduate program director specialized accreditation criteria, should an election take place rather than an appointment? We will discuss this issue again at our next Graduate Council meeting. We may invite Karen Mulitalo to the meeting to get her perspective.
