## Participation in Western Interstate Commission for Higher Education (WICHE)'s Western Regional Graduate Program (WRGP) Discussion

- The council discussed participating in the WICHE program which allows students in certain western states that apply to participating graduate programs to pay resident tuition.
- Each program would determine whether or not they want to participate. If the program wants to participate, the program director would inform Jim Bailey who would consult with the dean and vice-president designee before deciding whether or not the university would allow the graduate program to participate.
- Jim Bailey is the contact person for the university with WICHE. WICHE only wants to communicate with one person from each university.
- There will be further discussion to determine if current tuition waivers should be kept in addition to participating in WICHE. A cap could be set on the number of students participating in WICHE from each graduate program.
- Jim Bailey will be discussing with program directors, Linda Makin and John Curl. It will then go to AAC and President's Council for approval.
- A motion to support the process moving forward was passed.

## Graduate Studies Strategic Plan

- UVU needs to be more strategic in determining which degrees to offer.
- A motion to approve the draft and recommend that the draft go forward to AAC for discussion was passed.
