The council approved the following TOEFL Exception Guidelines:

UVU Policy 510 Section 4.5 3) requires TOEFL or IELTS scores for international students whose native language is not English. These guidelines provide Graduate Council approved TOEFL or IELTS exemptions. Applicants who meet one of the following exemption rules shall be considered English proficient, and shall not be required to take the TOEFL or IELTS to meet Policy 510 Section 4.5 3) minimum requirements. However, a graduate program may still require TOEFL or

IELTS scores if the graduate program requires higher TOEFL or IELTS scores than the minimum scores required in Policy 510 Section 4.5 3).

TOEFL or IELTS Exemption Rules

- 1. An applicant who earned a bachelor, master, or doctoral degree from a regionally accredited U.S. college or university shall be exempt from the university TOEFL or IELTS requirement.
- 2. An applicant who earned a bachelor, master, or doctoral international equivalent degree from a university of recognized standing in one of the following countries in which all instruction is provided in English shall be exempt from the university TOEFL or IELTS requirement: Australia, Canada (except Quebec), New Zealand, Singapore, the United Kingdom (England, Scotland, Northern Ireland, Wales), Ireland, Belize, the British Caribbean, the British West Indies, Guyana, and Liberia.

Being a U.S. citizen does not automatically exempt an applicant from taking the TOEFL or IELTS. If the applicant's first language is not English, the applicant must meet one of the exemption rules above or must submit TOEFL or IELTS scores.

If an international applicant meets at least one of the above TOEFL or IELTS exemption rules, the graduate program does not need to submit a Graduate Admission Appeal Form to the Graduate Council Appeals Committee for a TOEFL or IELTS exception for Policy 510 Section 4.5 3).

Graduate Program Director Recommendation for Proposed Policy 658-Graduate Programs

- 3.4 Add the word "academic" between the words program's and policies.
- 4.3.3 Change the word "department" to "discipline."
- 4.3.4 Change section to read as follows: Graduate program committees shall include one graduate student representative to participate in non-executive sessions of the committee. At the discretion of the graduate program faculty, graduate programs may have more than one student representative serve on the committee. The student representative(s) shall not participate in executive sessions of the committee.

Add the following section: 4.3.4.1 Under the direction of the UVUSA, graduate program students shall nominate students to serve on the graduate program committee. Nominated students are subject to approval by the graduate program committee. After students are nominated by graduate program students and approved by the graduate program committee, an election is held under the direction of the UVUSA to select the committee representative(s).

Add the following section: 4.3.5: The graduate program's dean may appoint a representative to serve on the graduate program committee.

Add Section 4.7 Graduate program college/school deans may provide oversight, staffing, and support for graduate programs in their college/schools for managing graduate program marketing, recruiting, interviewing, mentoring, internships, placement, graduation ceremonies, advancement, and alumni relations, as well as admissions application communications and processing. The dean's designee for these areas shall meet regularly with the graduate program director and graduate program committee where appropriate to discuss strategies and ways graduate program faculty can support these areas.

- 5.2.3 Change the section to read as follows: The non-executive session portion of graduate program meeting agendas shall be shared with all graduate program faculty one week prior to the committee meeting. Documents relevant to the meeting agenda shall also be shared with the graduate program faculty at that time. Normally, graduate program committee executive session agendas and documents shall be distributed on week prior to the committee meeting only to non-student committee members.
- 5.2.4 Change first sentence to read as follows: The non-executive portion of graduate program meeting minutes shall be shared with all graduate program faculty within one week after the graduate program committee approves the minutes.
- 5.2.5 Change section to read as follows: Graduate program committee members elected by the program's graduate faculty, the student(s) elected by the graduate program's students, and the dean's designee shall serve as voting members of the graduate program committee. Student representatives

shall not vote on graduate program executive committee matters. The graduate program director shall vote only when there is a tie vote.
