Annual Compliance Courses

Each year, UVU faculty and staff are required to complete compliance training courses in UVU Learn. Those courses include:

- UVU Cybersecurity
- UVU FERPA Training
- Title IX and Sexual Harassment
- Workplace Conduct
- Conflict of Interest

To access these courses, visit UVU Learn. In the **Learning Library**, you will find the courses under "Compliance Courses." Courses that need to be completed will have an option to start the course by selecting the "start" option. If you have already completed a course, you will be able to review that course by selecting the "review" option (which replaces the "start" option upon course completion).
