## INFORMATION ON SCHOLARSHIPS AND REIMBURSEMENT

Subject to availability of funds, all graduate students are eligible to receive scholarships for the graduate courses. Students should first pay the course tuition and fees. Upon receiving a receipt of payment, the reimbursement will be processed, usually within a few weeks after the start of the semester. Any Mathematics courses above the level of MATH 6000 are eligible for scholarship funding. Education courses that may be covered by the scholarship are EDUC 6100, 6200, 6320, 691R, 692R and 693R. Once the student is registered for MATH and/or EDUC courses, they should contact Dr. Christine Walker at <a href="mailto:christine.walker@uvu.edu">christine.walker@uvu.edu</a> so that she can process the scholarship.

**CONDITIONS FOR CONTUNUATION OF SCHOLARSHIP** The continuation of scholarship funding is dependent on satisfactory performance in each course. Each graduate student is allowed to receive reimbursements for a maximum of 18 credits in Mathematics and a maximum of 12 credits in Education. Continuing scholarships will be awarded uninterrupted for every student passing each graduate course until graduation. The following exceptions should be noted:

- Withdrawal or drop: If a student drops a course in the middle of a semester, any reimbursement of expenses pertaining to the dropped course must be paid back to UVU. If a student withdraws from the program in the middle of a course, any reimbursement of expenses pertaining to currently enrolled courses must be paid back to UVU. Reimbursement for any completed courses will not need to be paid back.
- **First occurrence of failing to pass**: Any grade below the level of B- is considered a failure in a graduate course. If a student completes a course but fails to pass the course, the student will be placed on probation and no reimbursement will be processed for the next graduate course until after the student successfully passes that course. If the student passes the next course, with a grade of B- or higher, the course fees will be reimbursed, and the scholarship will resume.
- Second occurrence of failing: A second occurrence of failing (for the same or a different course) will put a student under permanent probation and prohibit the student from receiving scholarship funding. The student can appeal in writing to the Graduate Program Director, to remove the probation. the Graduate Executive Committee will review the case and decide whether to restore the scholarship on a case-by-case basis.

## FINANCIAL AID FOR MATH 6000

Students taking MATH 6000 will be reimbursed in full for the course tuition and fees only after passing all the modules of the Qualifying Exam. Students may receive reimbursement for MATH 6000 only once. The 3 credits of reimbursement for MATH 6000 do not count towards the 18 credits maximum reimbursement for Mathematics courses allowed by the scholarship. A student is allowed a maximum of three attempts to pass the Qualifying Exam. A student may fulfill the requirements to enroll in graduate courses by directly passing the Qualifying Exam without taking MATH 6000. There is no fee to take the Qualifying Exam.
