


#### LITERATURE REVIEW






- RANDOM SELECTION OF 500 UVU STUDENTS OUT OF A TOTAL POPULATION OF 35,000
- 72 TOTAL RESPONSES
- 50/50 MALE/FEMALE
- EVEN THROUGHOUT SCHOOL LEVEL FRESHMAN TO SENIOR
- MAINLY AGES UNDER 35; LESS THAN 15% WERE OLDER
- ACCURATE REPRESENTATION OF UVU CAMPUS
- CONFIDENCE INTERVAL OF ABOUT 7; LEVEL 95%


#### SAMPLE SIZE AND RESPONSE RATE





#### SURVEY FINDINGS

- MAJORITY CONSERVATIVE
- FIREARM RIGHTS IMPORTANT BUT ONLY HALF THINK IT'S IMPORTANT ENOUGH TO MAKE AN IMPACT IN VOTING
- ABOUT HALF FOR STRICTER LAWS
- ABOUT HALF AGAINST



#### Concealed Weapons

Utah Valley University complies with state law with regard to weapons on campus. Utah state law clearly states that a person may not possess a dangerous weapon, firearm, or sawed-off shot gun on school premises (Utah Code 76-10-505.5) except under certain conditions. One of these exceptions indicates that this criminal statute is not applicable if the person is authorized to possess a concealed firearm as provided by the Concealed Weapon Law. UVU abides by this law and accordingly allows concealed firearm permit holders to possess their concealed firearm on campus. There is nothing specifically set forth in the Utah statutes that allows a concealed firearm permit holder to carry that firearm openly on a college campus. State statute defines a concealed dangerous weapon as being covered, hidden, or secured in a manner that the public would not be aware of its presence (Utah Code 76-10-501). As an institution, UVU respects the right of its students and others to legally carry a concealed firearm under those parameters, as outlined by state law.

#### UVU POLICY AND UTAH STATE LAW


- QUESTIONED STUDENTS ON FACTS OF STATE FIREARM LAWS AND UVU POLICY
- 1/3 HAVE MISCONCEPTIONS OF STATE CONCEALED CARRY LAWS AND STATE GUN LAWS
- MOST STUDENTS COMFORTABLE WITH UVU POLICY
- 30% HAVE NO OPINION
- 16% suggest a stricter policy for schools


#### SAFETY ON CAMPUS

- SAFETY AFFECTS ABILITY TO LEARN
- GENERALLY STUDENTS FEEL SAFE ON CAMPUS
- KNOWING SOMEONE WHO IS CARRYING FEELS SAFER
- KNOWING RANDOM PEOPLE CARRYING DOES
  NOT AFFECT STUDENTS
- STUDENTS DON'T BELIEVE THEY WOULD BE AFFECTED IF FIREARMS WEREN'T ALLOWED








#### CONCEALED CARRY

- IT'S MORE IMPORTANT THAT FACULTY HAS A
  CONCEALED PERMIT THAN ANYONE
- ONLY CONCEALED CARRY HOLDERS AND LAW ENFORCEMENT SHOULD BE ALLOWED TO HAVE FIREARMS ON CAMPUS
- MANDATORY TRAINING SHOULD BE REQUIRED IN THE CONCEALED PERMIT PROCESS

### STUDENTS WITH FIREARMS

- ABOUT HALF CURRENTLY OWN FIREARMS MOSTLY FOR PERSONAL PROTECTION
- 57% of firearm owners do not have a permit but feel they are ready
- MOST STUDENTS HAVE LITTLE TO NO EXPERIENCE
  WITH FIREARMS
- MORE LIKELY TO SHOOT RECREATIONALLY THAN FOR HUNTING, WORK, OR OTHER REASONS
- 25% GREW UP WITH NO ACCESS TO FIREARMS




Do you own a firearm?



#### FIREARMS AT UVU

- MAJORITY OF STUDENTS DON'T CONSIDER IT AN IMPORTANT FACTOR IN CHOOSING A SCHOOL
- MOST TEACHERS HAVE NOT DISCUSSED THE FIREARM
  POLICY TO STUDENTS
- ALLOWING WEAPONS ON CAMPUS DOESN'T MAKE THE SCHOOL MORE LIKELY TO HAVE A SHOOTING
- MORE STUDENTS FEEL BETTER KNOWING THERE ARE ARMED PEOPLE AROUND THEM DURING A CRISIS
- RECENT SHOOTINGS HAVE CAUSED MOST TO EVALUATE SURROUNDINGS MORE, STILL DON'T FEEL PREPARED

### EXPECTATIONS VS REALITY



- MOST STUDENTS FEEL SAFE ON CAMPUS WITH FIREARM POLICY AS IS
- NOT AS MANY KNOW THE GUN LAWS AS MUCH AS THEY THINK
- WILLING TO SUGGEST CHANGES EVEN THOUGH
  CONTENT WITH POLICY
- MOST STUDENTS HAVE LITTLE TO NO PERSONAL EXPERIENCE WITH FIREARMS
- ONLY 8 HAVE ACTUALLY BROUGHT A FIREARM TO CAMPUS
- ONLY A FEW STILL HAVE NEGATIVE FEELINGS
  TOWARD FIREARMS

### CONCLUSION

- MANY STUDENTS RESPECT RIGHT TO OWN AND USE FIREARMS
- MORE STUDENTS NEED TO BE AWARE OF FIREARM LAWS AND POLICY
- STUDENTS FEEL SAFE ON CAMPUS KNOWING
  THERE MIGHT BE STUDENTS CARRYING
- STUDY HABITS AND CONCENTRATION
  UNAFFECTED
- MANY STUDENTS WOULD LIKE TO SEE STRICTER
  FIREARM POLICY
