


Marijuana, Tobacco and Alcohol

The question of whether or not marijuana should be legalized has been at the forefront of public opinion and government for the last decade.

Because of this conflict of opinions, this was a main focus for our survey.



Marijuana vs. Tobacco




Tobacco is a legalized drug in every state. It is regulated at the federal level (FDA), while it is taxed federally and by state. The age restrictions varies by state, with 16 being the youngest legal age, and 19 the oldest.

Legal Marijuana is regulated at the state level, but is regarded as illegal by the federal government.


Marijuana vs. Alcohol

Pretty Even Distribution


Majority Vote: Positives outweigh the negative


Second: Equal positive and negative impact

Small Minority: No negative impact on society




Effect on Criminal Activity

Majority Vote: No (Half)

Second: Yes, but some drugs should stay illegal

Third: No, but people should be able to do what they want

Small Minority: Yes

Based on this survey...

About 95% thought that alcohol was either more dangerous or equally as dangerous as marijuana.

About 80% thought that tobacco was either more dangerous or equally as dangerous as marijuana.

About 25% supported the legal recreational use of marijuana with another 50% supporting legalization for medical use only.

44% leaned towards legalizing marijuana decreasing crime rates and 33% leaned towards legalizing marijuana not decreasing crime rates. The rest were unsure.

About 28% said that in legalizing marijuana there would be more positive outcomes than negative. About 27% said the outcome would be equally positive and negative. About 23% said that there would be some positive outcomes but majority would be negative.

About 45% said that legalizing all drugs would not result in better overall human life and society with 6% saying it would. About 26% said it would be better but some drugs would have to remain illegal and about 12% said that it would not result in a better life but that people have the right to do what they want.
