 - Better defines the responsibilities and obligations of Department Chairs
 - Acceptance to a three year term
- [Policy 654](#) Faculty Merit Awards (*Jon Anderson*) [4:35-4:50]
 - Limited Scope proposal
 - a. Aligning more with Policy 633: Faculty Annual Reviews
 - b. Removed the five year cycle so it becomes annual
 - c. Removing the timeline from the policy so that it can line up with policy 633 and tenure
