The U.S. Department of Education requires dependent students to provide parent financial information on their FAFSA. Students whose parents refuse to provide financial information on a student's FAFSA, and who also do not financially support the student, may be eligible to receive a Direct Unsubsidized Loan. Students in these situations are not eligible to receive a Pell Grant, Direct Subsidized Loan, or other need based financial aid. Interest begins accruing on a Direct Unsubsidized Loan as soon as the student receives the loan.

Providing financial support includes not only payment by the parent of educational costs, but also providing other cash and non-cash support to the student, such as room or board.

Students will be required to be enrolled in at least six credit hours, complete Loan Counseling and sign a Master Promissory Note with the U.S. Department of Education before their Direct Unsubsidized Loan will disburse.
