The First Semester Certificate in Art and Design is designed as your first step toward pursuing a degree in Art and Design. The program focuses on the foundational skills used in the field of Art and Design; successful completion of courses can lead to other degree goals and employment opportunities.

## HIGH SCHOOL

If you want to begin classes while in high school, make an appointment with a concurrent enrollment academic advisor early to plan for classes in an appropriate order based on availability at your high school and to discuss prerequisites. The First Semester Certificate may be completed in high school through the concurrent enrollment program, completed as an undergraduate on campus, or a combination of both. Once complete, the First Semester Certificate can be stacked with other courses to earn a Certificate of Completion, Associate's or Bachelor degree.

### **GRADE REQUIREMENTS**

Students need to pass Art and Design courses with a B- or higher to matriculate into the next program (portfolio reviews are also required for admission to some Art & Design associate and bachelor's programs). Students are required to submit a graduating portfolio upon certificate completion.



# EASILY BUILD FROM CERTIFICATE TO DEGREE PROGRAMS

### First Semester Certificate

#### **Graduation Requirements:**

- **1.** Completion of a minimum of 16 credits.
- **2.** Overall grade point average of 2.5 or above.
- All courses must be completed with a grade "B-" or higher.
  Portfolio Submission.

If long-range goal is AS or BS in A&D, take additional classes to stay on track for a 4-year graduation plan.

### Certificate of Completion

#### **Graduation Requirements:**

- 1. Portfolio Submission.
- **2.** Completion of a minimum of 30 credits.
- 3. Overall GPA of 2.0 or higher.
- **4.** Residency hours minumum of 10 credit hours through course attendance at UVU.
- If long-range goal is AS or BS in A&D, take additional classes to stay on track for a 4-year graduation plan.

## Associate of Applied Science

#### **Graduation Requirements:**

- **1.** Completion of a minimum of 60 semester credits.
- 2. Overall grade point average of 2.0 (C) or above. (Departments may require a higher GPA.)
- **3.** Residency hours minumum of 20 credit hours through course attendance at UVU.
- **4.** Completion of GE and specified departmental requirements.
- 5. Portfolio Submission.
  - If long-range goal is BS in A&D, take classes as outlined to stay on track for a 4-year graduation plan.

#### Bachelor of Science

#### **Graduation Requirements:**

- **1.** Completion of a minimum of 120 semester hours.
- 2. Overall grade point average of 2.0 (C) or above with no grade lower than a C- in all Art & Design courses.
- 3. ART 1110, ART 1120, ART 1130, ART 1400, and one of the following: ART 1050, ART 1350, ART 1420, or ART 1650 must be completed with a B- or higher before being formally admitted to the program.
- Residency hours minimum of 30 credit hours through course attendance at UVU, with at least 10 hours in the last 45 hours.
- **5.** Completion of GE and specified departmental requirements.
- 6. Portfolio Submission.

- **7.** Successful completion of at least one Global/Intercultural course.
- For the BA degree, completion of 16 credit hours of course work from one language to include the 1010, 1020, 2010, and 202G/2020 levels or transferred equivalents.
