Grantees have no obligation to exercise rights given by this License. I have no right to review or approve the Works. Grantees have no liability to me for Grantee's exercise of the grants in the first paragraph, or for distortion or other effects resulting from Grantees' exercise of those grants or Grantees' presentation of me.

To the fullest extent permitted by law, on behalf of myself and my licensors I irrevocably waive all legal and equitable rights relating to all liabilities, claims, demands, actions, suits, damages, and expenses, whether in tort, contract, or any other legal theory, now known or hereafter known in any jurisdiction throughout the world (collectively, "Claims") arising directly or indirectly from Grantees' exercise of their rights under this License whether resulting in whole or in part by the negligence of Grantees or any other person, covenant not to make or bring any such Claim against Grantees and their agents, employees, and representatives, and forever release and discharge Grantees from liability under such Claims.
