I. CALL TO ORDER

Chair James Clarke welcomed those in attendance to the April 28, 2022, Board of Trustees meeting.

II. INFORMATION

1. President's Report

President Astrid Tuminez began her report by highlighting the presidential and trustee awards of excellence. Dean Forrest Williams is retiring in June. UVU's dance teams celebrated a 1st place win in Jazz, 3rd place in HipHop, and 1st place in the combined event for the National Association of Collegiate Dance and Cheer in Daytona, Florida. Mechanical Engineering student, Matt Thomas, was featured on KSL.com regarding his prosthetic design project. UVU teams took 1st, 2nd, and 3rd place in regionals for the International Associate of Registered Financial Consultants financial planning competition and will be headed to Nationals. A few UVU colleagues have been recognized for their work, Tara Ivie and Sara Moore have been recognized by the Utah Women in Higher Education Network, Summer Valente by National Association of Student Personal Administrators, and Alessandro Zanazzi won 1st place at WxChallenge. UVU received a donation for \$3 M from the Miller Family Foundation for the Center for Constitutional Studies. The University hosted Governor Cox and Professor Peterson from the University of Utah. President highlighted commencement and that UVU will have 11,064 graduating students in 2022. The University had 8,729 in 2021 and 6,420 in 2020. Honorary doctorates will be given to Steve Lund, Karen Acerson, and the commencement speaker Mary Daly.

5. Strengthening our Dual Mission Commitment: Changes in Academic Affairs

Provost Wayne Vaught presented on the changes happening in Academic Affairs. The goal is to get students in the door, to keep them here, and help them graduate. Changes in leadership has created an opportunity for restructuring. Wayne highlighted the changes, which are designed to centralize academic support services, sharpen the focus on student retention and completion, enhance efficiencies, and to strengthen UVU's mission to educate all students.
