I. CALL TO ORDER

Chair James Clarke welcomed those in attendance to the October 20, 2022, Board of Trustees meeting.

II. INFORMATION

1. Leadership Updates

President Astrid Tuminez discussed changes in leadership.

2. Welcome and Oath for Kara North

Chair James Clarke welcomed and administered the oath to new trustee member Kara North.

3. Finance and Facilities Committee Report

Vice Chair Rick Nielsen provided the Finance and Facilities Committee Report by addressing the status of current projects at the University which included the Smith Engineering Building, Champions Building, Lehi Building 2, Student Center, Young Living Alumni Building, Losee Center move to the Woodbury building, academic move from the Browning Administration Building to the Losee Center, Soccer Stadium, and Center for Constitutional Studies. He mentioned UVU's team is responsive and thoughtful of these major projects.

4. Board of Engaged-Learning Award – 21/22 Reports & 22/23 Applicants

Associate Provost Tammy Clark presented the Engaged-Learning Awards. Sarah Santore and Clayton Rawson were present to say a few words regarding their projects and to answer any questions. Tammy presented the applicants for the 22/23 awards. Feedback needs to be back by November 11, 2022.

III. ACTION AGENDA

1. Program Approvals

Provost Wayne Vaught presented programs for approval, which included BS in Engineering Technology with emphases in Power Systems and Automation; CP Financial Planning; AAS Technology; BA/BS Economics; BS Technology Management; BA Deaf Studies; BA Deaf Studies- General Deaf Studies and Interpreting Emphases; and BA American Sign Language Secondary Education. Representatives from each respective school or college affected was present to explain the changes. Trustee Kara North motioned to approve the program changes as presented. Trustee Paul Thompson seconded. The motion carried without opposition.

2. 2022-23 Performance Goals

Vice President Linda Makin presented on performance goals. She highlighted the Commissioner's initiative to approve UVU's performance goals. Timely completion is the percentage of all students who have a timely graduation, which is still problematic because it does not measure the student body composition. 82% of students work while going to school which makes it more difficult to observe. UVU is focused on relevant education, not just STEM, but education in teaching, social work, and 4–5-star jobs, etc. The University needs more educators and mental health professionals. UVU has a strong K-16 Alliance, which helps to keep students applying for college and FASFA. School districts are continually working on a HS graduate exit survey and can ask for contact information regarding gap years. UVU fully expects to meet the goals by 26/27 year. Trustee Lexi Soto motioned to approve the performance goals as presented. Trustee Jill Taylor seconded. The motion carried without opposition.

3. Vision 2030 Refresh

Vice President Kyle Reyes began the Vision 2030 Refresh by recognizing Jeff Petersen and his team. Kyle stated that the heart of UVU's mission is student success. Vision 2023 has a strong mission and

vision statement which tracks to the University's dual mission model. Include, Engage, and Achieve were tightened up and reorganized to better communicate the vision of the University. UVU asked the trustees to be ambassadors in sharing Vision 2030. Trustee Rick Nielsen motioned to approve the Vision 2030 Refresh as presented. Trustee Jeanette Bennett seconded. The motion carried without opposition.

Trustee Blake Modersitzki motioned to approve the consent agenda, which included the Minutes of the August 25, 2022 Board Meeting, June and July 2022 Investment Reports, and the Institutional Discretionary Funds Report. Trustee Jeanette Bennett seconded. The motion carried without opposition.

3. President's Report

President Astrid Tuminez began her report by highlighting UVU's 6-win weekend, which included a 1st place win at the Financial Planning Challenge (FPC). UVU was recognized by the Hispanic Association of College and Universities (HACU); 2022 Constitutional Day "Recognition Amendments: The Roots of American Civil Rights." UVU hosted the United Nations "Why It Matters Conference" with over 1200 in-person and virtual participants. The University also hosted a Suicide Prevention Conference with over 1200 attendees, 18 presenters, and 17 sessions. UVU hosted Mike Pence and the Senate debate, which was widely covered and promoted. Upcoming events at UVU include the Scholarship Ball on October 22, the Growth and Prosperity Summit on October 28, and Presidential Lecturer Dr. Elazer Edelman on November 17. President also presented the final numbers of students attending UVU this fall semester. There are 43,099 students, 11,743 graduates with 34% first generation students. UVU is 2nd for graduates receiving 4–5-star jobs among all universities and college in Utah.

Chair James Clarke adjourned the meeting.
