### I. CALL TO ORDER

Chair James Clarke welcomed those in attendance at the November 29, 2022, Board of Trustees meeting.

### II. INFORMATION

## 1. Audit Committee Report

Trustee Paul Thompson provided the Audit Committee report by highlighting that DX continues to make efforts to increase IT security and to keep the University safe. Additionally, EthicsPoints hotline reports and President's travel were also reviewed.

### 2. 2023-24 Tuition & Fees Guidelines

The Director of Budgets, Scott Wood, discussed the 2023-24 tuition and fees guidelines. The current plan is to consider alternative funding sources before tuition increases are proposed. Guidelines were received from the commissioner's office which include the proposal date changed by a week (March 2), and the Board of Trustees Chair will present on March 16. UVU's tuition and fees process: Student Fee Advisory Board, UVUSA, President's Council, public hearing, Board of Trustees. There has been no official date set for truth in tuition. There are two date options for Board of Trustees to ratify fees, the February 23 or March 30 meeting.

## 3. Conflicts of Interest and Utah Open & Public Meeting Training

The General Counsel, Clark Collings, provided training on Conflicts of Interest and the Utah Open & Public Meetings Act. Trustees were given the annual disclosure statement to fill out and submit.

# 1. President's Report

President Astrid Tuminez began her report by highlighting that Jeanette Bennett will be inducted into the Silicon Slopes Hall of Fame. At Presidential Scholarship Ball, UVU launched the EverGREEN Campaign and raised \$501,000. UVU received its largest corporate gift, \$28.5M from UCCU. President thanked Kyle Reyes, Linda Makin, and Clark Collings for all their work on Vision 2030. Kara Schneck and her team have released the Annual Report. Dr. Bob Allen will be the new Woodbury School of Business Dean. Dr. Matthew Brogdon will be the new Senior Director of Constitutional Studies. The average attendance for PBA was 138. UVU hosted the Growth and Prosperity Summit. The Presidential Lecture series hosted Dr. Elazer Edelman. President spotlighted the Financial Planning students who won 1st place for the 5th year in a row. UVU also placed 1st and 2nd in the Wasatch Regional Ethics Bowl. UVU was recently ranked in the top 5 statewide for highest earning female residents.
