Course Title: Classical Architecture Workshop Credits: 4

### Course Description

Introduces the classical theories of architectural language, design, and craftsmanship in a hands-on studio setting. Focuses on the forms, spaces, and ordering systems of design as they are communicated through hand drawings in orthographic, perspective, and axonometric views. Applies understanding of classical building forms in the design of increasingly complex projects, from building details to large scale projects with landscaped site plans. Develops skills in traditional rendering and presentation techniques, including light through shade and shadow.

- o Apply proportion and geometry found in the natural world and the human form to designs

- communication Throughout the semester the instructor may contact students via email and/or Canvas.
