#### **Artist Reviews**

Students do three artist reviews in the course. The reviews are a response to artists they are looking at for inspiration while doing a project. The reviews have a few prompts for the students to answer like the sample below:

Prompt for carving artist review:

Paragraph 1 - After looking at the 5 artists (Brancusi, Arp, Noguchi, Moore, and Hepworth) which artist did you identify with the most? Articulate what it is about them and the way they work that you connect with.

Paragraph 2-3 - Pick a piece from artist you selected and describe it following the example given in class and the examples from the research. A. what helps it be a dynamic form, B. are there positive and negative spaces, C. as a biomorphic abstraction what does the piece bring to your mind.

- Brainstorming and refining your ideas;
- Fine tuning your research questions;
- Finding information on your topic;
- Drafting an outline to organize your thoughts; and
- Checking grammar and style.

If you can figure out how to use AI to sculpt your work for you I would be impressed. But it would defeat the purpose of taking the class.
