Another option is a Pochade Box which mounts atop a photo tripod. The Julien easel can double as your paint box, is portable, collapsible and is easy to set up. Great for apartments with little room to devote to your studio. Bring it to class and you will always have something to paint on.

Homework projects will require additional items. I have tried to keep these things inexpensive or possibly items that you already own.

Oil paints, oil painting mediums, and thinners are toxic. Remember to work in a well-ventilated space and keep your solvent container covered when not in use. Never allow a flame near your work area and do not smoke when handling solvents and mediums. Store and dispose of oil and solvent-soaked rags in metal cans only. If you have sensitive skin, consider using protective gloves and wearing protective eyewear. Make sure to wash your hands thoroughly after every painting session. Keep children and pets away from contact with paints, solvents, and mediums. If you accidentally ingest or splash any oil painting products, seek medical attention immediately.

Grading Policy

- 1. Late work will not be accepted for grading
- a. Deadlines for each assignment are given when projects are discussed. If work is not finished and turned in on the deadline you will fail that assignment and will not be allowed to complete that project for course credit.
- b. Completed projects are due at the beginning of the class period on the date defined in the course calendar. The beginning of the class period is defined as when the role is taken—after that time, work has missed the deadline and cannot be accepted for grading.

- c. Knowing that sometimes there are problems beyond your control or your instructor may require changes that will delay the completion of your project; an extension of the deadline requires instructor approval in advance.
- 2. Projects must be finished on the due date when we hold a brief class critique. Projects are then taken home to revise. Paintings will be turned in 1 week after the crit.

Students will have the opportunity to improve their work after the critique. Students are, in fact, required to make changes defined by the instructor during the critique (take notes). This is one of the most important aspects of student learning. It also parallels professional practices. All projects are to be photographed and uploaded on the due date via Canvas. Photos should be well-lit, in focus, and cropped to the edge of the canvas. Failure to provide descent images for grading will result in a reduced grade.

- 3. Each project will also include a brief written personal assessment statement.
- 4. Grading for this class is based on the student's ability to demonstrate these four criteria:

Appropriateness of the solution to the assignment, Design/Composition, Draughtsmanship, Craftsmanship (Skill with tools, neatness, and care)

A total of 100 points are possible for each project.

You are responsible for the information and creative output you submit based on any AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Your use of AI tools must be properly documented and cited to stay within university policies on academic honesty.

Any student work submitted using AI tools should indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting.
