In connection with my participation in the following class/lab _____ (“Class”), I understand that instructional sessions, interactive and adaptive simulations, and projects are video/audio recorded and photographed to facilitate learning and instruction.

I irrevocably grant Utah Valley University and its affiliates, successors, licensees, agents, and assigns (“UVU”) the rights to use audio, film/video, and photographs of me taken during participation in the Class (“Recording”) and to reproduce, prepare derivative works, distribute copies, perform publicly, display publicly, and perform publicly by means of a digital audio transmission the Recording or any other audio, video, or photograph of me in presentation slides or other materials I create for or provide to UVU during my participation in the Class (all of the foregoing, “Works”), in perpetuity, without compensation, and in any medium or format whatsoever now existing or hereafter created, on any platform, and in ancillary products, throughout the world for purposes related to the mission and programs of UVU.

Further, I hereby irrevocably grant UVU the right to identify me by name and use my name, image, likeness, appearance, voice, and other personal characteristics in connection with the Works, advertising and promotion of the Works, and materials created by or on behalf of UVU that incorporate any of the Works (collectively, “UVU Productions”) in perpetuity and in any medium or format whatsoever now existing or hereafter created.

Utah Valley University shall be the sole and exclusive owner of all right, title, and interest in and to the UVU Productions, including all copyrights and other intellectual property rights therein. I irrevocably waive any and all claims I may now or hereafter have in any jurisdiction to moral rights in the UVU Productions.

UVU has no obligation to exercise rights granted by this License. I have no right to review or approve the UVU Productions. UVU has no liability to me for UVU’s exercise of the grants herein, or for distortion or other effects resulting from UVU’s exercise of those grants or UVU’s presentation of me.

To the fullest extent permitted by law, on behalf of myself and my licensors I irrevocably waive all legal and equitable rights relating to all liabilities, claims, demands, actions, suits, damages, and expenses, whether in tort, contract, or any other legal theory, now known or hereafter known in any jurisdiction throughout the world (collectively, “Claims”) arising directly or indirectly from UVU’s exercise of its rights under this License whether resulting in whole or in part by the negligence of UVU or any other person; covenant not to make or bring any such Claim against UVU; and forever release and discharge UVU from liability under such Claims. I hereby: (1) acknowledge that UVU may incur significant expense in reliance on this License; (2) agree that this License cannot be terminated, rescinded, or modified, in whole or in part; (3) waive any right to equitable relief in the event of a dispute with UVU; and (4) agree that neither I nor my licensors have the right to enjoin or interfere with the production, distribution, exploitation, advertising, or promotion of the UVU Productions.

FERPA RELEASE: I understand that my educational record is protected by the Family Educational Rights and Privacy Act (“FERPA”) and that recordings of my image/voice while I participate in class may be protected by FERPA. I hereby authorize Utah Valley University to release the UVU Productions to faculty, staff, students, and third parties, including the general public. The purpose of the disclosure is to advance the educational mission of UVU.

I represent and warrant that: (a) I am eighteen years old or more and competent to contract in my own name; (b) my entering into this License will not violate my obligations to or the rights of a third party or require payment to, any third party; (c) I have not given anything of value to UVU or others associated with the UVU Productions in exchange for appearing in the UVU Productions or acknowledging me or including my name in the Works; and (d) I enter this License for the intangible value I will gain, and other good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge, without further consent from, or consideration to, me. The English language version of this License shall be controlling in all respects and shall prevail in case of any inconsistencies with translated versions, if any; any other language versions of this License are provided for convenience only.
