Fire Instructor I

- ☐ Prerequisites: None
- ☐ NFPA 1041, 2019 edition
- ☐ Written state certification exam consisting of 60 questions, passing score 70%
- ☐ Successful completion of a 15 minute (+/- 2 minutes) presentation, graded on a pass/fail basis.

Fire Instructor II

- ☐ Prerequisite: Instructor I or M-410 Facilitative Instructor
- ☐ NFPA 1041, 2019 edition
- ☐ Written state certification exam consisting of 70 questions, passing score 70%
- ☐ Successful completion of a 20 minute (+/- 2 minutes) presentation, graded on a pass/fail basis.

NEW Fire Investigator

- ☐ Prerequisite: none
- ☐ The UFSCC strongly suggests that the chief/administer conduct a background investigation for members of their agency who are tasked with the responsibility of being the fire investigator. The position of fire investigator should be filled by an individual that could withstand an intense investigation by a defense attorney who would look to discredit an investigator. The cost for a background investigation is minimal and would be the responsibility of the agency.

Fire & Life Safety Educator II

- ☐ Written state certification exam consisting of 80 questions, passing score 70%
- ☐ Successful completion of an approved Fire & Life Safety Educator II Portfolio Process

Fire Officer I

- ☐ Prerequisites: Hazmat Awareness, Hazmat Operations, Firefighter I, Firefighter II, Instructor I or M-410 Facilitative Instructor, minimum of three (3) years' experience as a member of an organized fire department
- ☐ NFPA 1021, 2019 edition
- ☐ Written state certification exam consisting of 100 questions, passing score 70%
- ☐ Skills state certification exam consisting of three (3) skills, graded on a pass/fail basis

Fire Officer II

- ☐ Prerequisites: Officer I, Instructor I or M-410 Facilitative Instructor, certified in two specialty areas: ADO-Aerial, Hazmat Technician, Inspector I, Fire Investigator, Instructor II, Rescue Technician; successful completion of the NIMS ICS-300 Course; successful completion of the Fire Officer II Leadership project and experience of 5 years with an emergency response agency
- ☐ NFPA 1021, 2019 edition
- ☐ Written state certification exam consisting of 100 questions, passing score 70%
- ☐ Successful completion of a 20 minute (+/- 2 minutes) project presentation
 - Completion of NIMS ICS-300
 - 5 years of experience at an emergency response agency
 - Specialty requirements (i.e., ADO-A, Hazmat, Fire Inspector, etc.) see requirement form
 - Completion of required course (i.e., CTC, NFA - ICS, etc.), see requirement form

Fire Officer III

- ☐ Prerequisite: Officer II
- ☐ NFPA 1021, 2019 edition
- ☐ Written state certification exam consisting of 50 questions, passing score 70%
- ☐ Successful completion of an approved Officer III Portfolio Process
 - Completion of NIMS ICS-400
 - 6 years of experience at an emergency response agency
 - Completion of a required course (i.e., CTC, NFA - ICS, etc.), see requirement form

Fire Officer IV

- ☐ Prerequisite: Officer III
- ☐ NFPA 1021, 2019 edition
- ☐ Written state certification exam consisting of 50 questions, passing score 70%
- ☐ Successful completion of an approved Officer IV Portfolio Process
 - 7 years of experience at an emergency response agency

Utah Wildland Firefighter I (NWCG Firefighter II)

- ☐ Prerequisites: Candidates must show completed copies of NWCG/FEMA certificates S-130, S-190, I-100, L-180, and I-700 (as outlined in PMS 901-1) to the tester prior to testing.
- ☐ NFPA 1140, Chapter 4, 2022 edition
- ☐ Written state certification exam consisting of 50 questions, passing score 70%
- ☐ Skills state certification exam consisting of 3 skills, graded on a pass/fail basis
- ☐ If online course was taken, candidate must provide copies of module completion certificates for S-130/S-190 to the tester prior to testing. Certificates will be submitted to the UFRA Wildland PM before an NWCG Certificate will be issued.

Utah Wildland Firefighter II (NWCG Firefighter Type I)

- ☐ Prerequisites: Wildland Firefighter I. Candidates must show a completed copy of their NWCG/FEMA certificate S-131 (as outlined in PMS 901-1) to the tester prior to testing. Candidates must have a completed and certified NWCG Firefighter I task book from an authorized organization (i.e., State of Utah, BLM, U.S. Forest Service, etc.). (Attach a copy of the Verification/Certification on page 2 of the completed task book, with their training record.)

- ☐ Written state certification exam consisting of 50 questions, passing score 70%
- ☐ Skills state certification exam consisting of 3 skills, graded on a pass/fail basis
- ☐ Prior to testing, candidate must have completed/Certified NWCG Firefighter I task book from an authorized organization (i.e., State of Utah, BLM, U.S. Forest Service, etc.). Attached copy of Verification/Certification (page 2) of completed task book.

NEW Technical Rescue - NFPA 1006, 2021 edition

The new Technical Rescue standard for NFPA 1006, (2021) has been separated into individual standards, due to the new additional levels: Awareness, Operations, and Technician.

- Please note, “Chapter 5” was removed from the new Technical Rescue and is not a prerequisite for the new.
- Due to the high level of skill required for a Technical Rescue, applicants must pass an in-house comprehensive exam on all skills contained in the standard.
