The Firefighter 1 is an entry-level position requiring basic certifications and no previous experience in the fire service. The Firefighter 2 is certified firefighter with 2-4 years' experience and additional certification requirements above Firefighter 1. Both positions will work a 48/96 schedule as part of a shift team. Successful candidate will assist to provide fire prevention, protection, and a safe and effective emergency response to personnel and facilities. Other responsibilities include assisting in the administration of emergency medical treatment; inspection of building fire systems, conducting motor test standbys, burning ground standbys, training, flare drops, special assignments, animal control, and evacuation drills -along with all other duties assigned.
