Summary of 2015 General Legislative Session: Action Impacting UVU

The following is a summary of legislative action impacting Utah Valley University from the 2015 General Legislative Session. Noted appropriations come from the General and Education Tax Funds. For ease of reference, below this text summary are the specific House and Senate bills (by item number) that contain legislation impacting UVU.

UVU's top budget priorities for the 2015 legislative session were 1) Compensation, and 2) Mission Based Funding. Compensation will be funded with an equivalent of a 2% cost of living allowance and a 4.9% health insurance benefits rate increase for higher education employees (total \$2,561,800 ongoing). 75% of these compensation increases will be funded by state tax funds; 25% is to be funded through a 1st tier tuition rate increase. No Mission Based Funding initiative was funded.

Three other significant budget items impacting UVU were funded to the State Board of Regents: 1) the *Education Excellence Initiative* (a.k.a., Performance Based Funding) at \$8,020,000 (\$2,020,000 ongoing plus \$6,000,000 one-time funds), 2) the *Engineering Initiative* at \$4,500,000 (\$3,500,000 ongoing plus \$1,000,000 one-time), and 3) the *Math Competency Initiative* at \$1,825,000 (ongoing). All of these initiatives will be administered through the State Board of Regents and UVU's share of these funds has yet to be determined. (NOTE: UVU is obligated to match any funds allocated through the *Engineering Initiative*.)

UVU's top capital facilities priority for the 2015 legislative session was the funding of its Arts Building. While three buildings within the Utah System of Higher Education (USHE) were funded, the UVU Arts Building was not. However, the legislature has granted UVU the authority to expend institutional or donated funds for the design and planning of the facility, which positions it for funding (less any privately raised funds) during the 2016 session. An additional capital facility appropriation of \$1,500,000 was made to remodel the UVU Activity Center (PE courts) to increase its capacity and functionality to better accommodate athletic, campus and community events.

(Item 133) Engineering Initiative @ \$4,500,000 (\$3,500,000 ongoing plus \$1,000,000 one-time) to State Board of Regents. UVU's anticipated allocation is: TBD, which is to be matched by institutional funds for a total impact of: TBD.

(Item 130) State Board of Regents – Student Assistance @ \$2,583,700 (ongoing). This appropriation is to fund the Regents Scholarship.

(Item 134) Education Excellence (a.k.a., Performance Based Funding) @ \$8,020,000 (\$2,020,000 ongoing plus \$6,000,000 one-time) to State Board of Regents. This allocation is targeted to improve institutional performance based on metrics (e.g., participation, retention and completion rates) as outlined in *SB232 Higher Education Performance Funding*. HB0036S01: *Veteran's Definition* – Institutions within the state system of higher education may grant resident student status to any student who has come to Utah and established residency for the purpose of attending an institution of higher education, and who, prior to registration as a resident student. HB0197S01: Educator Licensing Amendments – A local school board or charter school governing board may request a letter of authorization permitting a person with outstanding professional qualifications to serve in any position that requires a person to hold an administrative/supervisory license or certificate, including principal, assistant principal, associate principal, vice principal, assistant superintendent, administrative assistant, director, specialist, or other district position. HB0198: Strengthening College and Career Readiness – Creates the Strengthening College and Career Readiness Program, a grant program for local education agencies, to improve students' college and career readiness through enhancing the skill level of school counselors to provide college and career counseling; directs the State Board of Education to: develop a certificate for school counselors that certifies that a school counselor is highly skilled at providing college and career counseling; award grants to local education agencies, on a competitive basis, for payment of course fees for courses required to earn the certificate. HB0218: *Nurse Practice Act Amendments* – Amends the requirements for a nursing education program to qualify as an approved education program; amends the division's rulemaking authority related to limited-time approved education programs. HB0282S01: Online Education Program Amendments – Bill expands the entities that may offer secondary school level and concurrent enrollment courses through the Statewide Online Education Program and authorizes institutions within the state system of higher education to offer secondary school level and concurrent enrollment courses through the Statewide Online Education Program. HB0312S01: *Reporting and Expenditure of Public Funds Amendments* – A written description and itemized report submitted by a state agency to the Governor's Office of Management and Budget under Section 63J-1-220 including: (A) a written description and an itemized report provided at least annually detailing the expenditure of the state money, or the intended expenditure of any state money that has not been spent; and (B) a final written itemized report when all the state money is spent. HB0214S01: *Money Management Act Amendments* – Modifies provisions relating to authorized deposits or investments of public funds; provides for a transition of investments that were previously authorized; and repeals provisions relating to the State School Fund report. HB0337S02: Career and Technical Education Comprehensive Study – Creates the CTE Board within the Department of Workforce Services; Commissioner of Higher Ed- Member. Link to bill: http://le.utah.gov/~2015/bills/static/HB0337.html

SB0175S02: *School Safety and Crisis Line* – Requires the University Neuropsychiatric Institute, within the University of Utah Hospitals and Clinics, to establish a statewide School Safety and Crisis Line; removes the sunset provision for the School Safety Tip Line Commission and renames it the School Safety and Crisis Line Commission. SB0223S01: *USTAR Governance Amendments* – Requires that prospective gubernatorial appointees to the Utah Science Technology and Research Governing Authority be approved by the Senate; gives the governor authority to remove a member of the Utah Science Technology and Research Governing Authority before a member's term is completed; modifies provisions of the technology outreach innovation program; and makes technical changes. SB0239S01: *Retirement Withdrawal Modifications* – Allows certain withdrawing entities to make an election to withdraw from participation in a Utah retirement system or plan for current and future employees in certain circumstances; requires the withdrawing entity to pay certain costs that arise out of the election of the withdrawal. SB0253: *Exceptions for Privately Funded Scholarships* – This bill modifies provisions related to verification requirements for receipt of state, local, or federal public benefits.
