
## My Second Experience at the UN Commission on the Status of Women

On March 21st, 2022 it was my great pleasure to participate for a second time in the 66th Session of the UN Commission on the Status of Women through a virtual parallel event to advocate for mountain women and as our contribution to the observation of the <u>International</u> <u>Year of Sustainable Mountain Development, declared by the United Nations General</u> <u>Assembly last December.</u>

This UN document acknowledges that, "despite the progress that has been made in promoting the sustainable development of mountain regions and the conservation of mountain ecosystems, including their biodiversity, the prevalence of poverty, food insecurity, social exclusion, environmental degradation and exposure to the risk of disasters is still increasing, particularly in developing countries, and access to safe and affordable drinking water and basic sanitation as well as to sustainable modern energy services continues to be limited."

Although I had to attend the event through a recording due to other commitments, I was able to provide a brief <u>statement</u> on the cause of sustainable mountain development to the Commission. As President, it was also my responsibility to share my insight from organizing our parallel event during CSW65 with head of the delegation, Ms. Alitha Thompson, UIMF Vice-President.

Over the course of the last year as President of the Utah International Mountain Forum (UIMF), a coalition of student clubs at Utah Valley University (UVU), it has been my great honor to watch our students work together on various initiatives with focus on the advocacy of mountain communities over the past year and the results of their efforts as they hosted this event via the Student Engaged Learning (SEL) model. SEL encourages students to work as a group on certain practical issues and learn professional skills while university faculty mentor them in that endeavor. Through months of collaboration by using the SEL model, student members of the UIMF have been able to teach each other and students and faculty of Osh Technological Institute in the mountainous Kyrgyz Republic, as well as Snow College in Utah, how to jointly not only handle logistics and preparations for this event but also their own presentations advocating for the mountain women and girls to be in the focus both of the CSW66 and 2030 Agenda for Sustainable Development.

We express thanks to our sponsors such as Russian Academy of Natural Sciences, Utah China Friendship Improvement Sharing Hands Development and Cooperation, two nongovernmental organizations in consultative status with U.N. This event, hosted by UVU students through the SEL model demonstrated why UIMF was highlighted for mountain women advocacy by the United Nations Secretary General's Report on SMD in 2016 and 2019, the only student group globally, and how through SEL our coalition became a full-fledged contributor to the implementation of the 2030 Agenda for Sustainable Development with a special focus on mountain communities, families and women.
