



# STUDENT FEE INFORMATION

## What is a student fee and who decides what they go towards?

By definition a general student fee is any university-wide fee assessed upon registration to students. Revenue from these fees is used to pay for programs, facilities, and services that are determined to be essential for the enrichment and broadening of opportunities for students. This does not include tuition, course fees, and special fees for particular courses, groups, or majors (UVU Policy 511 3.1).

At the beginning of spring semester every year, the UVUSA Student Council holds Student Fee Hearings. Any department or organization on campus who currently receives funding from student fees or would like to receive funding from student fees must come present to Student Council. The presentations are reports on how the money has been spent; requests for continued funding or increases, as needed; and, most importantly, how these expenditures benefit the student body. These meetings are open to the public and Student Council encourages student participation. The Student Fee Hearings will take place from mid-January through mid-February, between 1-3pm on Thursdays. Specific dates will be announced at the beginning of Spring semester.

After the conclusion of the Student Fee Hearings, the UVUSA Executive Council (Student Body President and the Vice Presidents) prepare a Student Fee Proposal. The proposal is presented to, reviewed and voted on by the General Student Fee Board, UVUSA Student Council and President's Council. Once passed by these entities, it is presented to the UVU Board of Trustees and finally to the Utah State Board of Higher Education for final approval.

## What are my student fees going towards and how much are they?

| FEE DESCRIPTION               |   |

| <b>Student Programs</b>       | Fee shall be used to fund the personnel and operations of Student Life programs (ie: Clubs, Student Conduct, Volunteer and Service Learning, UVUSA, Student Media, etc.).   |
| <b>Campus Recreation</b>      | Fee shall be used to fund personnel and operations of Campus Recreation programs (ie: Intramurals, Outdoor Adventure Center, Climbing Wall, Club Sports, etc.)  |
| <b>Building Bonds</b>         | Fee shall be used to pay the debt service associated with the bonds (similar to a mortgage) for the Student Center and Student Life and Wellness Center.  |
| <b>Student Center O&amp;M</b> | Fee shall be used to pay the expenses incurred for the personnel, operations and maintenance for the Sorensen Student Center.   |
| <b>SLWC O&amp;M</b>           | Fee shall be used to pay the expenses incurred for the personnel, operations and maintenance for the Student Life and Wellness Center.  |
| <b>Athletics</b>              | Fee shall be used to pay the expenses incurred for the personnel and operations for the athletic program participating in the NCAA in both the Western Athletic Conference and Big 12 Conference. Beginning in 2020-2021 \$1.00 of the fee will be dedicated to the costs associated in providing programming and marketing surrounding the student section (The Den) experience. |
| <b>Health Services</b>        | Fee shall be used for personnel and operating expenses incurred for medical health services provided to students through the Student Health Services office.  |
| <b>Student Computing</b>      | Fee shall be used for the maintenance and replacement of open lab computers across campus. Fee eliminated as July 1, 2021.  |
| <b>UTA</b>                    | Fee shall be used to provide partial coverage of the annual UTA contract for bus, Trax and Frontrunner services for students.   |
| <b>Arts</b>                   | Fee shall be used to subsidize student ticket prices to student productions sponsored by the School of the Arts.  |
